PROFIT WARNING

This announcement is made by Mindtell Technology Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance, Chapter 571 of the Laws of Hong Kong.

Based on the information currently available to the board of directors (the “**Directors**”) of the Company (the “**Board**”), including the preliminary review of the latest unaudited consolidated management accounts of the Group, the Board wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that the Group is expected to record a decrease in revenue for the six months ended 31 May 2019 (the “**2019 Interim Revenue**”) by approximately 62.0% as compared with that of the corresponding period of 2018. The Group is also expected to record a decrease in profit before listing expenses for the six months ended 31 May 2019 (the “**2019 Interim Profit**”) by approximately 87.2% as compared with that of the corresponding period of 2018.

The expected decrease in 2019 Interim Revenue and 2019 Interim Profit were mainly due to the following reasons:

- (i) the implementation phase of the existing large-scale IT projects of the Group, including Project W (as defined in the prospectus of the Company dated 29 September 2018), have been substantially completed. Up to 31 May 2019, over 80% of the Project W has been completed; and thus the revenue contribution of Project W to the total revenue of the Group decreased accordingly in which it only contributed to approximately 21.1% of the total revenue of the Group for the six months ended 31 May 2019 as compared with that of approximately 78.2% of the total revenue of the Group for the six months ended 31 May 2018; and
- (ii) incurrence of additional administrative expenses including directors’ emoluments and legal and professional fees after listing of the shares of the Company on GEM of the Stock Exchange on 22 October 2018.

The information contained in this announcement is only based on the information currently available to the Board, including the preliminary review of the unaudited consolidated management accounts of the Group, which have not been audited or reviewed by the auditors and the audit committee of the Company.

The Company is still in the process of finalising the Group's financial results for the six months ended 31 May 2019. Shareholders and potential investors of the Company are advised to read carefully the interim results announcement of the Company for the six months ended 31 May 2019, which is expected to be published on or around 10 July 2019.

Shareholders and potential investors are advised to exercise caution when dealing in the Shares of the Company.
